



STATEMENT OF UNDERSTANDING FOR ENTRANCE TEST AND INTERVIEW (ONLINE) WITH SAN YU ADVENTIST SCHOOL (SYAS)

Dear Parent(s) / Guardian / Applicant,

Thank you for choosing San Yu Adventist School (SYAS). Please note that sitting for the entrance test (online) does not guarantee the applicant a place as a registered student in our school. This test (online) allows the school to assess the applicant's academic suitability, and selection is based on merit, vacancy and interview. Applicant will only be confirmed the entrance test and interview (online) if the required documents are fully submitted

Terms and regulations

1. The total Application and Entrance Test fee is SGD750 and non-refundable, even if the applicant does not show up for the test or interview (online). Full payment is to be made before registration to confirm participation for the entrance test and interview (online). An official receipt will be issued to the applicant.
2. The applicant and the appointed guardian must go through all the Pre-Course Counselling materials provided, failing which the result of the application will be delayed and the vacancy may be given to another applicant. The school does not reserve the place for any applicant.
3. Primary 3 to Secondary 3 applicants are required to sit for 2 test papers via the online testing platforms: English and Mathematics. P1 and P2 applicants will be given their tests during the interview session.
4. The applicants are responsible for ensuring that they are able to access the online testing platforms. There will not be a refund of the application and test fee if the student is unable to access the testing platform on the test date itself.
5. External help, mobile phones, smart watches, dictionaries / electronic dictionaries are not allowed during the course of the interview and test (online). Scientific calculator can be used for Secondary 2 and Secondary 3 applicants.
6. The invigilators reserve the right to terminate / remove any student if he/she is found cheating or exhibit irregularities during the test and interview (online).
7. The results of the application will be released within one month from the online test date and **no grade will be given**, only **"Successful"** or **"Unsuccessful"** application will be informed through email.
8. The school reserves the decision-making rights in the approval of the applicant's admission based on the outcome of the entrance test and interviews (online). **No reason will be given for non-acceptance**.
9. Please note that there will be no refund / compensation of any fee should the applicant fail to meet the entrance interview test standards and requirements.
10. Please note that the result of our school entrance test (online) does not entitle the applicant to other school's entry requirements. It is only exclusive to admission in SYAS.
11. Getting an offer from the school does not guarantee the applicant a Student's Pass or Letter of Consent. Applicant must obtain the approval letter from ICA before he/she can officially sign on as a student in our school.
12. The entrance test papers and scripts are the property of the school and will not be released to any applicant.
13. For matters not provided for in this agreement, applicant/guardian/parent have to bear the responsibility to clarify any doubts.

Declaration by Parent/Guardian

1. The applicant and I agree to comply with the terms and regulations listed above.
2. I declare that the applicant did not have poor conduct in his/her previous schools.
3. I will withdraw the applicant from the school if I do not fulfill any of the above or is discovered to have contravened any of the above after being admitted into this school.
